# 3. Criminal Damage/ ASB Report

The group went through the report.

The group decided to concentrate on projects for young people to reduce criminal damage and ASB across Newhaven.

## 5. Funding 2007/2008

CH informed the group the budget for 2007/2008 was £10,700 with a split of £5,200 Capital and £5,500 Revenue. There were no project proposals brought to the meeting. It was decided by the group that any project proposals would be sent to LY a week before the meeting, so that everyone has time to read them and a decision can be made at the meeting.

# 6. CRP Update

CH fed back some of the items discussed at the CRP meeting.

### 6.1 Funding 2006/7

 CH updated the group that the CRP has distributed all remaining funding for 2006/7. For the second year running, funding the Local Action Teams directly has proved to be a very successful method, although some LATS have slightly overspent. Pubwatch "Radiolinx" device

Although there are severe cuts in the budget, it will be possible to maintain funding of the core staff with the additional new position of part time Community engagement Officer, the core projects such as CADDIE the CRP is committed to funding as well as increasing the budget of the Local Action Teams.

Regarding the Dire and Rescue Service's Life project, it was decided that once the appropriate young people have been identified, contributions from the LATS could be considered.

## 6.2 Update on latest crime statistics

CH reported that CI Neil Moscrop elaborated on the latest update on the British Crime Statistics figures, concentrating on the targets in red.

Theft of a pedal cycle still remains in the red area, although numbers remain small and are no cause of concern. The main problematic issue is Criminal Damage which accounts for 30% of all crime in the District. There is a correlation between Criminal Damage and substance misuse, but also with school patterns.

### 7. Resident Associations update

#### **Hanson Road**

LY informed the group that Hanson Road Resident Group had organised their first community event. It took place over the Easter weekend and was very successful. They are in the process of opening their bank account. They have organised an action plan which the group is working toward.

SM mentioned that the group of young people from the Hanson Road area have been engaging well with the youth workers. The group regularly attend the youth club on a Monday night at Lewes Road Rec and during the Easter holiday the youth workers had organised a climbing wall specifically for that group which proved very popular and was a successful day.
